Any information that is obtained in connection with this study and that can be identified with you will remain confidential and will be disclosed only with your permission or as required by law. In an effort to further examine the faculty experience, the Higher Education Research Institute may be interested in conducting follow-up research. We will consider you as a potential participant only if we have your explicit permission to do so (survey question #45). As part of its agreement to participate in this survey, your institution has agreed not to examine your individual responses to any question. Any research your institution performs must be conducted on groups of faculty only.
